## 1. VOTING PROCEDURES

- 1. Each individual will register upon entering the Assembly meeting
- A coaching representative from each club will receive one voting card for the Assembly. The
  coaching representative may vote on all the motions presented at the Assembly. Therefore, each
  club will receive <u>ONE VOTE</u> on motions presented. All clubs participating must be a member in good
  standing with Gymnastics Ontario.
- 3. Proxy Voting:
  - 3.1. Any club representative may carry a maximum of two (2) proxy votes for individuals who are unable to attend the Assembly meeting.
  - 3.2. Notification of proxy voting must be signed by the club conceding the vote.
  - 3.3. All proxy notifications (i.e., Proxy Vote Form) must be submitted to the Men's Program Manager prior to Monday, April 17, 2023. <u>There will be no exceptions to these stipulations</u>.
  - 3.4. If any individual/club representative needs to leave during the assembly, they must return their voting cards to the Registrar, or see the Registrar to complete a proxy form in order to pass their voting card(s) to another individual or club representative.
- 4. Notification must be given to the Men's Program Manager and/or the Registrar if an individual must leave the room at any time during the Assembly meeting to ensure accuracy in the counting of votes.
- 5. Voting Procedures:

Speakers on the motions in order:

- 5.1. Mover of the motion speaks first.
- 5.2. MTC can respond with clarification/interpretation/position.
- 5.3. Voting delegates (excluding the mover) who wish to speak are permitted to speak only once to each motion.
- 5.4. Mover of the motion speaks last.
- 5.5. Voting occurs.

Note: If the votes do not balance against the registered list after numerous tries, but there is a quorum, the Assembly will continue but the actual vote count will be noted in the minutes. This is to avoid delays with clubs going in and out of the Assembly room.
