4 Summary of Membership Requirements

- 1. Clubs must register with Gymnastics Ontario by **June 16, 2023**.
- 2. Clubs must carry the full Gymnastics Ontario Insurance Policy.
- 3. All recreational and competitive athletes, coaches, judges, supporters, and staff must be registered with payment with Gymnastics Ontario and carry the Gymnastics Ontario Insurance.
- 4. All gymnastics related organizations residing in, or sharing the same facility as, a G.O. member club must also be registered members of Gymnastics Ontario and carry the Gymnastics Ontario insurance.
- 5. A Full Member will be considered to include any formal or informal organization that is in any way (directly or indirectly) controlled, materially influenced, affiliated, associated or connected to the Full Member and may be a group of participants, registrants, class of member, or a company corporations, subsidiary, branch or satellite operation, "feeder" group or "booster" group or club like organization. The establishment of such separate entities in order to circumvent this or any other G.O. membership requirement may be considered an act of misrepresentation of or by the Full Member, contrary to principles of ethical conduct, and may result in disciplinary proceedings and consequences as determined by the Board of Directors in its discretion.
- 6. All member clubs are required to:
 - Respect and abide by all Gymnastics Ontario By-Laws and Policies. (Refer to Appendix B).
 - Abide by the Corporation Act and update annually as required.
 - Meet and continue to update all criteria for club registration.
 - Register with Gymnastics Ontario all recreational gymnasts, competitive athletes, coaches, judges, and supporters, including board members/staff who are members of the club.
 - Continue to update all individual registrations on an ongoing basis.
 - Submit all appropriate fees on behalf of their members in accordance with G.O. policy
 - Submit all requests for accompanying documentation.
- 7. It is the club's responsibility to keep Gymnastics Ontario advised of any club changes that would prevent compliance with the outlined expectations. It is important to all involved that registration updates and payments are kept current. We expect every club to respect and abide by all the set deadlines, and there are penalties in place if these responsibilities are not met.

MEMBERSHIP REGISTRATION

5 Club Renewal Information

- 1. Gymnastics Ontario's registration year starts on July 1, 2023 and ends on June 30, 2024.
- All accounts should be settled by <u>June 16, 2023</u>. Please note that post-dated cheques that are dated past the invoiced due date will not be accepted. All membership renewals are conditional on full settlement of accounts.
- 3. All clubs <u>must</u> be registered by <u>June 16, 2023 at 3:00 pm</u> for the 2023-2024 season. Clubs that do not open until September should contact the G.O. Membership Services Manager prior to <u>June 16, 2023</u>, at 647-598-1915 or <u>membership@gymnasticsontario.ca</u>.
- 4. To be considered fully registered as a **club**, Gymnastics Ontario must be in receipt of the following:
 - A complete Club Membership Application.
 - The Full Club Membership Fee of \$630 + HST.
 - The annual Music License Fees for SOCAN (\$75 + HST) and Re:Sound (\$55 + HST) or the completed Music License Statement Form.
 - o The *Music License Statement Form*, 2023-2024 is available on www.gymnasticsontario.ca/forms.
 - A zero balance of fees from the previous season.
 - If applicable, Recreational Club and Birthday Party registration fees
 - o HST must be paid at the time of registration, the fees may be paid using the installment method
- 5. A penalty of \$200 is applied if the club is not fully registered as of <u>June 16, 2023 at 3:00 pm</u>. If the club membership fee and penalty are not received by <u>June 27, 2023</u> the renewal period closes and the club <u>will cease</u> to be a member effective <u>June 30, 2023 at 11:59 pm</u>. The club must register as a new member club after <u>July 1, 2023</u> and provide the following: the club membership fee, the late fee, full payment of any outstanding fees and all documentation that is required when applying as a new club.

6 Annual Club Fees

- 1. Full Club Membership Fee: The fee to become a Gymnastics Ontario Member Club is \$630 + HST. Clubs must pay this fee annually to be an active member. Approval of club membership is pending renewal or new club application requirements.
- 2. Music License Fees: In order to ensure compliance with Canadian copyright law, every club that uses music which contributes to the actual gymnastics or fitness activities in your gym (AM/FM radio, satellite/internet, physical/digital media such as, CD, mp3, etc.) will be charged an annual fee for a SOCAN Music License and a Re:Sound Music License. If a club does not use music in any way in their programs, that club will be required to sign a statement to that effect and submit it to Gymnastics Ontario advising that they will be responsible for the fee directly if SOCAN and/or Re:Sound subsequently finds that the club is in fact using music and issues an invoice to the member club. As this is a service to members intended to be a simple flow-through, Gymnastics Ontario will not be responsible for any charges that SOCAN and/or Re:Sound makes to clubs who have declared that they do not use music. See *Music License Statement Form, 2023-2024* available on gymnasticsontario.ca/forms.
 - **SOCAN Annual Fee:** Every club that uses music will be charged \$75.00 + HST for the SOCAN Annual Fee. SOCAN (the Society of Composers, Authors and Music Publishers of Canada) is a not-

for-profit organization that represents the Canadian performing rights of millions of Canadian and international music creators and publishers.

- **Re:Sound Annual Fee:** Every club that uses music will be charged \$55.00 + HST for the Re:Sound Annual Fee. Re:Sound is the Canadian not-for-profit music licensing company dedicated to obtaining fair compensation for artists and record companies for their performance rights.
- **3.** Recreational Club Fee: Any club offering a recreational program must declare this in their club membership account and pay the Recreational Club Fee of \$615 + HST by October 15, 2023. Note: The HST portion of the fee is due at registration.

As per the motion below, small clubs can request a reduced recreational program fee.

• 9.2 Recreational Programming Fee for Small Clubs That a sum of money be set aside beginning in fiscal year 2010-2011, up to \$9,000.00, for clubs with less than 100 members, who require assistance from the CEO in paying their annual recreational programming fee.

Submit the completed Request for Recreational Club Fee Reduction (refer to **Appendix E**) to the Membership Services Manager by September 30, 2023.

4. Birthday Party Fee: Clubs that host birthday parties must verify this in their club membership account and pay the fee of \$525 + HST by October 1, 2023. <u>Note</u>: The HST portion of the fee is due at registration.

As per Policy 04.04.26, the following regulations must be followed when hosting birthday parties:

- Participants must be supervised at all times by a coach certified at the appropriate level required: registered "Coach of Recreational Gymnast" minimum.
- For insurance reasons, a record of attendance is mandatory. G.O. does not require the club to register
 each participant but it is required that the names, addresses and telephone numbers of the individuals
 who participated, and the date must be recorded for each party and must be kept on file at the club
 and be available on request.

7 Individual Membership Information

<u>All individual participants</u> must be registered <u>within 15 days</u> of becoming newly active or annually reactivated with a member club to have insurance coverage. Clubs must make payment within 15 days of being invoiced.

Individual participants include athletes, coaches, judges and supporters. Supporters include the club's / organization's Directors, Executive, committee members, administrators, staff and volunteers who provide help and/or services on a regular and ongoing basis.

If participants are active in more than one discipline, level or role, they must be registered in all applicable memberships.

Clubs must enter the following data when registering individual participants in the online membership registration system:

- First name & last name
- Date of birth
- Gender
- Home address (**Note:** please do not use the club's facility address)
- Phone number (**Note:** please do not use the club's facility phone number)

<u>This is required</u> for reporting and insurance purposes and for maintaining accurate membership records.

8 Determination of Individual Membership Fees

- For individuals registered in more than one category, Gymnastics Ontario assigns only the highest fee applicable per registrant, rather than a charge on a per registration basis. **Note:** This does not apply to Unattached Coaches or Foreign Participants.
- **Individual Insurance Fee** is the fee each participant must pay to be covered by the Gymnastics Ontario insurance program with Gallagher Insurance. For more details about insurance coverage, please visit https://www.gymnasticsontario.ca/insurance.
- Athlete Program Fee is the required fee, in addition to individual insurance, for registered athletes. This
 fee covers Gymnastics Canada's membership fee and all the services that Gymnastics Ontario offers. For
 more details about member benefits and Gymnastics Ontario services, please visit
 https://www.gymnasticsontario.ca/member-benefits.
- All membership fees are non-refundable. Refer to page 9 for details about competitive athlete membership deadlines.
- To determine what athlete membership is required for a particular level, please refer to **Appendix C** on page 17.

9 Registration by Roles

1. Coach

• All coaches must be registered within 15 days of beginning coaching activity and the club will be invoiced the insurance fee of \$26.50 + HST.

a. Pre-CIT / CIT (Coach in Training)

- If a person (aged 13+) is interested in getting involved in a coaching capacity, they may be registered as a Pre-Coach in Training (CIT)
- If a new coach is over the age of 16, but has yet to complete or enroll in the Foundations program, they will be registered as a CIT.

b. Recreational Coach

- Coaches registering in this category are indicating that they coach strictly at the recreational level.
- The **minimum** training requirement for this category is to be NCCP Level 1 Certified or Foundations Trained in the discipline(s) they are coaching.

c. Invitational/Interclub Coach and Provincial Coach

- Coaches who are training athletes for interclub/invitational and/or provincial competition must be registered in this category.
- Coaches must be minimum of Level 2 Certified or Competition 1 Trained in their respective discipline(s) and complete their MED Online Evaluation and Respect in Sport to take athletes onto the competition floor.

d. National Coach

- Coaches who are training athletes for national competition must be registered to this category.
- Coaches must be **minimum** NCCP Level 3 Trained (and Level 2 Certified) or Competition 2 Trained (and Competition 1 Certified) in their respective discipline(s) and complete their MED Online Evaluation and Respect in Sport to take athletes onto the floor.

e. Unattached Coach

This role is reserved for individuals who will be attending an NCCP Education Course but are not
associated with a member club. These individuals must submit the <u>Unattached Participant</u>
<u>Registration Form</u> to the Membership Manager. Unattached coaches that are later registered by a
member club may be required to pay the membership fee for their first registration by a club.

Note: Coaches need only to register at the level they will be coaching in the current season. If eligibility requirements are not met, a coach's registration is not considered valid. For further explanation of Coaching Certifications please visit www.gymnasticsontario.ca/education or contact: Education Manager at education@gymnasticontario.ca.

2. Competitive Athletes

 All competitive athletes must register within 15 days of starting a gymnastics activity and the club will be invoiced the insurance fee of \$26.50 + HST and Athlete Program Fee at the time of registration. Competitive Athlete Program Fees are as listed below.

i) Invitational / Interclub Athletes
 ii) Provincial Athletes
 iii) National Athletes
 \$100 + HST
 \$225 + HST
 \$325 + HST

- Please consult the supplemental document, <u>Appendix C</u> Tentative Competitive Athlete Levels, to
 determine what membership to register athletes for. Any updates to level selections will be sent to clubs
 and will be available at <u>www.gymnasticsontario.ca</u>.
- Clubs can adjust the athletes' levels any time up until **October 15**. Contact Membership Services to downgrade a competitive athlete's membership to receive a credit for the difference in fees; however, credit will only be provided until the October 15 deadline. Final changes to levels must be made by October 15. Please note competitive athlete program fees are non-refundable after the October 15.
- Athletes are to be registered at the level they are training throughout the season and intend to compete at.
 Up/downgrades are acceptable but are subject to eligibility as specified in the Technical Rules & Regulations through the Program Manager.
- For further explanation of competitive levels please consult the appropriate Program Manager.

3. Recreational Athletes

- All recreational athletes must be registered with Gymnastics Ontario within 15 days of starting a
 gymnastics activity and the club will be invoiced the insurance fee of \$26.50 + HST and the Recreational
 Athlete Program Fee of \$5.00 + HST.
- Recreational athletes include participants in parent & tot, kindergym, recreational gymnastics; as well as the categories listed below:

a. ODP / Demo / Showcase

- RG ODP, WAG ODP ages 6, demo and showcase athletes <u>are not</u> considered to be competitive and should be registered as recreational athletes and pay the \$26.50 insurance fee + HST and the Recreational Athlete Program Fee of \$5.00 + HST.
- WAG ODP ages 7 and up are considered Invitational and are required to pay the Invitational Competitive Program Fee of \$100.00 + \$26.50 insurance fee + HST.

b. Masters Athletes

 Athletes that are 18+ can participate at the Masters level. These individuals are not considered to be competitive and should be registered as recreational athletes and make payment of \$26.50 insurance fee + HST and the Recreational Athlete Program Fee of \$5.00 + HST.

c. Drop in Participant

- Participants can attend drop in classes at more than one club; however, the participant must register
 and make payment of \$26.50 insurance fee + HST and the Recreational Athlete Program Fee of
 \$5.00 + HST to the member club on their first visit.
- Every drop in participant must show proof of membership at every visit, or the individual must pay the registration fee.

d. Private Lessons

 All individuals participating in private lessons must be registered with Gymnastics Ontario within 15 days of starting gymnastics activity and pay the insurance fee of \$26.50 + HST and the Recreational Athlete Program Fee of \$5.00 + HST.

e. Ninja Participants

- All individuals participating in Gymnastics Ontario sanctioned ninja programs must be registered with Gymnastics Ontario within 15 days of starting gymnastics activity and pay the insurance fee of \$26.50
 + HST and the Recreational Athlete Program Fee of \$5.00 + HST.
- Participants of ninja programs <u>not sanctioned by Gymnastics Ontario</u> should not be registered with the Federation. Additional insurance is required for non-sanctioned activities. Contact the Operations Manager, <u>operations@gymnasticsontario.ca</u> for more information.
- To request sanctioning for your ninja program, contact the Gymnastics for All Program Manager at gfa@gymnasticsontario.ca.

4. Trial Participant / Promotional Visitor

- There is no fee associated with this role.
- A participant may have 3 visits (class trips, bring a friend, class trial) at a club before a membership is required.
- Clubs need to keep records and information must be kept on file by the club for insurance purposes. <u>After 3 visits</u>, clubs must register these athletes with Gymnastics Ontario.

5. Camper (up to 5 days)

- A pro-rated insurance charge of \$11.00 + HST will be applied if a camper attends up to 5 days of camp.
- Please note that Summer Camps are part of the new season's registration and must be registered accordingly.

 Campers (summer, March Break, P.A. days, etc.) may attend up to 3 times under the Trial Participant/Promotional Visitor Policy. If the athlete returns for more than 5 days of camp or signs up for a fall/winter/spring session, they must be registered as a recreational athlete and the remaining \$26.50 insurance fee + \$5.00 Recreational Athlete Program Fee + HST will be applied.

6. Judges

- The Judge's Fee for the current season is \$26.50 insurance fee + HST.
- Judges must be registered by October 15, so that the disciplines can determine the availability of judges for competitions. Judges are required to select the discipline and the highest level they are eligible to judge (ODP Assessor, Beginner, Club, Interclub, Invitational, Provincial, National or Brevet).
- Judges must complete the Competitive Athlete and Coach Participant Personal Information and Code of Conduct, 2023-2024 form and send it to the appropriate Program Manager.

7. Supporter

- The Supporter Fee for the current season is \$26.50 insurance fee + HST.
- Includes the club/organization's Directors/Executive, committee members, administrators, staff, facilitators and volunteers who provide help and/or services on a regular and ongoing basis.
- For supporters *not* associated with a member club, refer to the *Unattached Participant Registration Form* found on the Gymnastics Ontario website, www.gymnasticsontario.ca/forms.

8. Learning Facilitator

- Learning Facilitators will be registered by Gymnastics Ontario each year.
- Learning Facilitators active in another role with a Gymnastics Ontario Club will be charged for the first registration. Discounts will be applied to subsequent registrations as per the **Determination of Individual Membership Fees** on page 8.

9. Life Membership

a. Ontario Life Membership

- Reserved for those who have received the honour of a Life Membership.
- These members will be registered by Gymnastics Ontario each year.
- If a Life Member also exists in another role with a Gymnastics Ontario Club, there will be no charge for the membership fees.

b. Olympic Athlete Life Membership

- Reserved for those who have received the honour of an Olympic Athlete Life Membership.
- The competitive athlete program fee and membership insurance fee will be waived for Olympic Athlete Life Members who are still actively competing.
- Olympic Athlete Life Members are to be registered within 15 days of starting a gymnastics activity at the level they are training throughout the season and intend to compete at.

10. Foreign Participant

- This registration category is reserved for athletes, coaches and judges who train and compete primarily outside of Canada but will be attending a G.O. sanctioned event or club in Ontario. The fee is set at \$50.00 + HST.
- **For Training Purposes Only:** For participants that train more than one time in an Ontario club but are not active in the Ontario competitive system, they must be registered with an Ontario member club through normal G.O. registration procedures. Registration must be in duality with an existing registration with their respective gymnastics' federation/organization. We also require that this member be in good standing with their own federation to be considered eligible.
- **For Competition Purposes Only:** Participants attending a G.O. sanctioned competition are required to complete the *Foreign Participant Registration Form* (refer to www.gymnasticsontario.ca/forms) and submit with the required fee, a minimum of 2 weeks prior to the competition. These individuals must be members in good standing with their respective gymnastics' federation.

11. Out of Province Participant

• There is no registration fee; however, the participant must provide proof that they are registered with their respective provincial gymnastics' federation.

12. Caregivers / Aides / Assistants

- The caregivers/aides/assistants shall be involved only in a non-coaching/non-teaching role. They are there to support the participant in what the coach is asking the participant to do.
- The assistant and the participant must remain under the direct supervision of the coach at all times.
- All clubs must keep an accurate and up-to-date list of caregivers/aides/assistants for each class. This list must be kept on file at the gymnastics club for insurance purposes.
- This list should include information about the name of class, date, coach's name, and time of the class together with the name of the caregivers/aides/assistants, addresses, and phone numbers, and also the name of the child who is participating in the class with them.
- Caregivers/aides/assistants are automatically covered under liability insurance but not for Sports Accident Coverage. If Caregivers/aides/assistants want Sports Accident Coverage they must register with Gymnastics Ontario.

10 Individual Registration Forms

All forms can be saved and stored electronically. Be sure to label the file by the participant's name and registration year for accurate record keeping and retrieval. A copy is to be kept on file at the club.

A. Competitive Athlete & Coach Participant Personal Information & Code of Conduct

- All competitive athletes, competitive coaches and judges must complete and sign the Personal Information
 & Code of Conduct form; <u>a copy is to be kept on file at the club.</u>
- Unattached judges must complete the form and send it to the appropriate Program Manager or the Membership Services Manager at membership@gymnasticsontario.ca.
- Only when an athlete, coach or judge qualifies to represent Ontario at Eastern Canadian Championships, Canadian Championships or on a Tour Team should they submit the form to the attention of the appropriate Program Manager.

B. Competitive Athlete Medical Data Record

- All competitive athletes must complete and sign the Medical Form; a copy is to be kept on file at the club.
- All coaches should have a copy of the Medical Data Record in their possession during training and all
 competitions and training camps that their athletes are attending (in the event that an injury occurs when
 the parent is not present).
- Only when an athlete, coach or judge is representing Ontario at Eastern Canadian Championships, Canadian Championships or on a Tour Team should they submit the form to the attention of the appropriate Program Manager.

C. Participant Informed Consent and Assumption of Risk Agreement (Recreational & Competitive)

- Gymnastics Ontario and/or the Insurer may request an audit to verify the completion of these forms.
- These forms must be kept on file at the club until 2 years past every individual's 18th birthday.

13 Membership Invoices and Payments

Membership fees are invoiced to the club's online account immediately after completing a registration.

Invoices can be viewed at any time by logging into the club's online account.

Payment is to be received by the Gymnastics Ontario office within 15 days from the date the invoice is issued. Membership invoices can be paid (i) online by credit card (Visa/MasterCard), Interac Online or Visa Debit or (ii) offline by cheque made payable to Gymnastics Ontario, 2950 Keele Street, Suite 202, Toronto, ON, M3M 2H2.

If at any time, you believe there is a discrepancy with an invoice, please contact the Membership Services Manager immediately. All discrepancies must be reported to Membership Services no later than 30 days from the invoice date. Adjustments cannot be made to the 2023-2024 membership account once the season ends on June 30, 2024.

14 Late Penalties for Unpaid Invoices

Late penalties for unpaid invoices will be assessed as follows:

Individual Insurance Fee

Competitive Athlete Program Fee

- All competitive athletes must register within 15 days of starting a gymnastics activity. The club will be invoiced the Individual Insurance Fee and the Athlete Program Fee at the time of registration.
- Clubs can adjust the athletes' levels any time up until October 15. Contact Membership Services after downgrading a competitive athlete's membership to receive a credit for the difference in fees; however, credit will only be provided until the October 15 deadline.
- Final changes to levels must be made by October 15. <u>Please note competitive athlete program fees are</u> non-refundable after the October 15 deadline.
